### Turf Field

Mike Masciarelli reviewed Turf Schedule:

LYSA has field reserved for practices/games starting Monday 3/31 to 6/14. Monday thru Friday 5:00 pm – 8:30 pm, Saturdays 8:30 am – 4:00 pm. LYSA also has 3 selected Sundays.

Adult soccer league has also reserved turf for Friday nights after LYSA activities starting in June.

Water at the bathrooms need to be turned on, Bob will contact Jack to arrange for turn on.

### Marshall Park Baseball Field

Bob Robuccio reported that Marshall Park Baseball field is still unplayable, alternate arrangements and schedule changes are taken place until the field is ready for use. The LHS baseball schedule is available on the schools web site.

Lunenburg Phillies schedule is still not completed, practice/try-out times will start as soon as the field is ready. Practice/try-outs are scheduled for every Tuesday, Thursday and Saturday until league play
