LTC/FID CHECKLIST

In order to facilitate the completion of your License to Carry Firearms or Firearms Identification Card application in a timely manner, the following item(s) are needed before issuance:

- Firearms Safety Course Certificate – **1ST ISSUE ONLY**
Must be a Massachusetts certified course including course # and instructor #
- 3 letters of recommendation (not from family/no form letters) – **1ST ISSUE ONLY**
- Copy of birth certificate – **1ST ISSUE ONLY**
- Permit fee of \$100.00 (**\$25.00 fee for FID applicants under the age of 18**)
(No permit fee if over 70 years of age on RENEWALS ONLY)
- Check made payable to: ***“Town of Lunenburg”***
- Complete set of fingerprints – **1ST ISSUE ONLY** (completed at the station)
- Be sure questions 2-15 are answered correctly** (*even if charges were dismissed, you must give details on space provided following #15 on the application*)
- Signed Information for Question #4**
- References must include street address, city, state, zip, & a **valid phone number**.

Please make sure all questions are answered completely.

License to Carry/Firearm Identification Card Information for Question #4:

Please read this entire document carefully. Initial all of the following paragraphs and sign the bottom of the page, certifying that you have read and understand the document.

- Question 4 on the application asks, “Have you ever been arrested or appeared in court as a defendant for any criminal offense?” The key word is **APPEARED**, not necessarily arrested. You do not have to put down non-criminal (civil) traffic offenses, for example speeding or equipment violations. You **DO** need to list all criminal traffic offenses for example, suspended license, revoked license, unlicensed, uninsured. Please ask if you have any questions or need clarification on what should be listed on the application. _____
- Understand that “ever appeared” includes all adult and juvenile appearances. It does not matter if you were found not guilty or if the charges were dismissed or continued without a finding; you have to put it down. **IF YOU DO NOT ANSWER TRUTHFULLY WE WILL FIND OUT**, no matter how long ago. _____
- If you have a sealed record, you need to let us know. (You do not have to tell us what is in the sealed record). The Firearms Licensing Officer gets notified of sealed record disqualifiers. _____
- The licensing authority will not accept, “I forgot” or “They told me it would not show up”, “It never showed up before”, “I didn’t think that mattered” or “That was so long ago.” It is up to the licensing authority to thoroughly complete the background check and vet all applicants for suitability. _____
- Make any and all changes now. Remember, you are signing under the Penalties of Perjury and will be denied a license if you do not complete the application truthfully and completely. Nondisclosure of your criminal record, omissions and false information, and untruthful answers **will result in a denial** and you may face court prosecution for perjury or providing false information on a firearm application pursuant to M.G.L. Chpt 140 Sec 129/A. _____
